# Free State Region October Meeting Report

Good morning,

Happy New Year!!!

This is new year and with all things new it brings some changes. Today will be my last report at the Region. As Roger is ready to step up to his RCM position, we offer him our best wishes. As a seasoned member, I am sure he will represent the area well.

I attended the On-Month Regional meeting on December 10, 2022. Eight (8) areas were in attendance and two sub-committees Phone line, and PR.

The following points were discussed.

# 1) Free State Convention- Wayne

- a) Everything went well. Among the members who attended the Convention, there were 1021 who were pre-registered and 485 registrations sold on-site for a total of 1506 participants at Free State.
- b) The final breakdown of pre-registration shows that the two-tiered systems continue to grow. Last year there were about 35% of pre-registration for addicts < 3 years, this year the number has increased to a little bit more than 50%.
- c) After all expenses, seeds money, and prudent reserve have been taken into consideration, the convention did generate an excess of \$20,000.00. The board will meet later this month to decide what to do with the money.
- d) There were a few policies changes implemented or enforced this year:
  - a. All board members should pay for everything at the convention including meals.
  - b. Any board member, if necessary, is removed by majority vote.
  - c. Nepotism is still being addressed. No preference given to family members.

d. Term limits of 6 years is being enforced. After those 6 years, a member must sit for another 6 years before being eligible to come back.

# 2) Service Center: Jeff

- The service center received the annual letter from the world re-affirming the 22.5% discount from literature purchases.
- Literature sales continue to increase up to \$41,200.00 this month.

# 3) East Coast Convention

- Mike R, a representative from the East Coast Convention of NA, paid us a visit. The last Convention was held at the Bay area and East of the Bay on the 3<sup>rd</sup> week of 2021, in Chestertown. Because of COVID regulations at that time, attendance was restricted. A total of 350 people were at the Convention.
- The goal of this convention is to offer a Convention at affordable costs to new comers and used the proceeds to buy books for the jails and/or prisons. They brought cases of books to be distributed among the areas at Free State for the incarcerated addicts. More details are included in the Free Stat Report attached

# 4) Chair: Larry

Suggested a few topics for discussions: Region to have hybrids meeting during Off-Months only, having foods during on-month, jobs sharing (for example to alternate secretary duties between on-months and off-months, regional inventory and continue updating archives. Reminded there are still some open positions at the Region. Complete Report in Free State Report attached

# 5) RD: John

- CAR report is out. This year, the world will not issues printed versions. It is available for download on-line at NAWS.
- The RD is setting February 15<sup>th</sup> as the deadline for areas to bring the tally filled by homegroups. The Regional service meeting around that date will be on Saturday February 11 which should be the real date to bring the responses.
- AZF met November 21 and 28. A candidate from Philly was interviewed for the facilitator position. It was filled.
- > The next meeting for AZF will be the week after MARLCNA.
- The RD was asking if the Region is willing to consider self-funding the delegates to participate at the World Conference? This was a request made by the world asking to consider self-funding. If a Region can't or denies the request, the World

will continue funding. A motion will have to be made for funding of RD on top or RDA.

- > John is also asking the Region to consider contributing funding to AZF as well
- Finally, John is asking if areas want future CAR workshops?
  - i. Some possible locations could be at the Service Center or by invitation from individual areas.
  - **ii.** The workshops can also be hybrids, virtual, or live.
- We did ask a question to the RD about home groups filling surveys directly at the world. I was informed that not only this practice might hinder the proper conscience of the area, but It can also cause the vote of these homegroups to be diluted.

# 6) Policy facilitator:

Policy up to date through May 22. Cleaning and updating the policies. Updating motion forms to allow submission by sub-committee as well as RCMs. More details in Free State Report.

- One RCM suggested to eliminate the off-month meeting altogether and to only meet every other month. There were quite a few discussions. Some members were offering instead of meeting in-persons during on-month and hybrid during off-months.
- The chair and policy chair asked the areas to remind their sub-committees chairs or vice-chairs they need to start showing up again at the Region to meet prior to Region as it was in the past. I mentioned to the Executive body the decision was made a few months back by the sub-committees to keep meeting virtually. They will look back in the archives for details regarding that decision.

- Motion 1: Submitted by Policy Chair Sam, seconded by Mike B from Bay area-To reimburse PR chair, Sam \$290.00 for printing schedule booklets distributed at the Regional Convention. Motion passed 8/0/0
- Motion 2: Submitted by Jeff M, North East Freedom area, seconded by Mario A, Baltimore area- One-time \$475.00 representing 1/3 of the total costs to support Baltimore and NEFTA areas for the bus signage project. Each area will support 1/3, \$475.00 for a total cost of \$1,400.00. Motion passed
- Motion 3: Submitted by Alexis M Small Wonder area, second by Randy K, Bay area- To eliminate off-months meetings. Motion tabled
- Motion 4: Submitted by Mario A, Baltimore area, seconded by Jeff M, North East Freedom area-. Request a one-time print of 500 Regional schedules. Motion tabled.

## 12) Nominations:

Michael C Volunteered his nomination for H&I Regional Chair. The nomination passed with unanimous consent.

# **13)** General/Open discussions:

There were talks regarding operations at the Free State Convention, and to suggest having each area included in the Convention board in order to supervise the designated committee assigned to that area. Discussions will continue in offmonth.

## BASC Public Relations Subcommittee Report

January 7, 2023

Good afternoon, Baltimore Area Service, Executive Committee Members, and Group Service Representatives (GSRs) –

> What was your drug using like? My using was similar to what's described in our Basic Text, Narcotics Anonymous. In essence, I used drugs every day and only thought about getting more drugs and the money to pay for the drugs. What we have found most important in recovery is that we identify with each other in meetings, focus on recovery from addiction, and do not compare our use of drugs. Many addicts had the same feelings while using drugs, and this is a source of identification for members. [From NA.org]

- I. The December 2022 Public Relations Subcommittee meeting was held on Monday, Dec. 26. This was a virtual meeting. The meeting opened and closed with the "We" version of the Serenity Prayer. Regular Subcommittee meetings are held on the 4<sup>th</sup> Monday of each month on Zoom at 6 pm.
- II. Last Month's Meeting Schedules (Pricing Update)
  - a. FSRNA printed 500 schedules for the FSRNA Nov. 2022 Convention.
  - b. Time Printers give us a price quote of \$120.00 of 500 eight-page Baltimore-Only schedules.

We're reached out to CPRCNA's Convention Information Chair to find an offset printer who can print more schedules (1000 plus) at a cheaper price.

- III. New meetings:
  - Putting the Pieces Back Together has started meetings on Saturdays at 6:00 pm 7:30 pm; 1200 W. Baltimore St. (Open discussion, Steps 1-3) - This meeting needs support.
  - ii. The Truth Will Set You Free (still pending) 2504 Linden Avenue (at Whitelock), Saturdays at 3:30 or 4:00 pm (TBD
- IV. Bus Signage:

We finalized the Baltimore Area locations for the bus signage project, identifying the following two locations: Park Heights Ave.-Belvedere and Edmonson Ave-Poplar Grove. FSRNA has approved payment of one-third of the \$1400 total cost, leaving \$467 remaining for both Baltimore Area and NEFA. NEFA has also approved payment of its share. Baltimore Area PR requests approval from the GSRs of \$467 for the Baltimore share. Upon approval, the design work is ready to go to have bus hut signage in place by early February 2023 if not sooner.

## V. Learning Day w/ H&I

Due to low attendance at the Dec. 28, 2022 planning meeting, we recommend postponing the schedule Jan. 21, 2023 PR/H&I Learning Day to spring 2023 to allow additional time for more active involvement.

PR selected the following potential topics:

- 1. What Is PR
- 2. Being In Service
- 3. Our public image: creating confidence in NA
- 4. Using PR resources to assist in reaching the medical community, criminal justice, and those who refer people to NA

The event would be 3 hours: w/15 minute speakers or skits, alternating between PR and H&I, with a 15 minute half-time for refreshments + 10 minutes of Q&A between first and last hour.

# Free State Region of Narcotics Anonymous Chairperson report for December 10, 2022



Good morning to Free State Regional members. As always, I want to thank each NA member who loves there recovery and is taking time to be of service at our level. During our November meeting, we cover a few thing. We still have so much more work to get accomplish. With a sense of unity and focus, things moved very smoothly during the meetings.

There is a need to address and change somethings in order to keep up with the current times and to make Service at the Regional level more appealing to other NA members. Here are some of the things I have notice and think that with changes, will have more NA members stepping forward into Service. As all the RCM know, I cannot make any changes. My role is to facility and not govern.

Can we consider continuing our hybrid meeting on the Off-Months only? This would limit travel time to the Region to only six times per year. The Off-Months are used for discussion and have a clearer picture of what we are to vote on in the next On-Month meeting. Cost, time, and travel would be cut in half.

It was mention that we could ask the FSRSC if we could provide something to eat again, but we would need to be at the Regional meeting for that to happen. I suggest asking for our On-Month meeting only at this time. The Service Center is doing everything they can to support our Region. We must take them in mind when making our decisions.

I was asked, who is paying for the RCM's CAR report? I suggest we ask our current **RD** and then the RCM's can decide on it.

Also, if we met only on On-Months and hybrid on off months, we could consider job-sharing of some of our positions (for example, the secretary position, where one secretary will be present during On-Months and another can help with the minutes during the Off-Months meetings remotely).

We need to prepare and proceed with a Regional Inventory for which we need a policy facilitator. This would provide more time for everything to be updated, along with what we currently are discussing in our Region. By being here during our On-Months meetings, and remotely during the Off-Months meetings, it would make it easier to see the entire picture and to be better prepare to give us what we need.

We still have some very key positions that we need to fill. We need to give the NA member something different than what we have been doing, if we truly want more to get involved.

The FSRCNA appeared to be a success. I will leave that for their Chairperson to update us and answer our questions.

We need to make sure that the information and work we do can gets to all of our Areas, and placed on our website for anyone to access.

The 12<sup>th</sup> Concept comes closes to what I am asking our Region to seriously consider some changes "In keeping with the spiritual nature of Narcotics Anonymous, our service structure should always be on of service, never of government." When we leave it to the few to handle NA business with no rotation or new members getting involved, we leave the door open for newer member and other outside entities to get the wrong impression of who we are and why we do what we do. Please RCM's if we do not have time to address these concerns today, let's do it in the near future. We can accomplish this if we make time and work together.

I am Mike R and I was on a committee that won the bid for East coast Convention 24 at ECCNA 23 in Florida in June 2019. We intended to hold the convention in 2020 at Washington College in Chestertown, but due to covid this was a difficult service commitment. The purpose of the East Coast Convention is to hold an affordable convention for new comers and to use the proceeds from the convention to buy basic texts for jail.

Our committee was predominantly folks from Bay area and East of the Bay Area. Originally the service meetings rotated between bay and east of the bay and then everything went to zoom and even on May 31 2021 it seemed like we might not hold the convention in Chestertown in just 3 weeks.

#### Bidding Guidelines ECCNA CONVENTIONS

Requirements in submitting bids to the ECCNA:

- 1. A Letter of Support from all sponsoring NA Area(s)/Region(s) must be submitted via the Bid Committee together with the bid. This is to be signed by Chairperson of the Sponsor, together with their contact information.
- 2. A Letter of Intent (to hold the Event) from the facility and a Facility Fact Sheet must be submitted with the Bid
- 3. The ECCNA Advisory Board (AB) must receive written bids no later than the 30 days prior to the current years' convention. At that time, the AB will review the bids for guideline compliance. (Please see ECCNA.org for Host Policy)
- 4. The Bids will be created and represented by a "Bid Committee" consisting of willing NA members from the bidding NA Area/Regional Community. This committee may be either formed by themselves with Area/Regional Sponsorship or directly by the Sponsoring body (s). Components of this service body will include the Admin part of a "Host Committee", (see Section 7 of "Host Policy", "Host Committee").

#### Suggestions:

1. Each bid should be sponsored from an Area/Region where there has been an active ASC/RSC for two years.

2. Historically, the convention has been held at a school campus where housing and food tend to be affordable in the off season (June). The Full Registration includes all costs including room, board and meals. Day registrations and combination Day registration/meal packages may be offered as approved by the AB.

#### How it Works:

In order for an Area/Region be eligible to host the convention, they must first submit a bid package to the AB through a "Bid Committee". A group of NA members may approach and Area/Region to secure their support and thereby form a bid committee. The bid must be submitted at least thirty (30) days prior to current year convention and is for the next year's convention. This bid must be in writing, reflect the Conscience of the Area(s)/Region Service Committee(s) and be signed by the Chairperson and Vice-Chairperson of the ASC(s)/RSC(s) along with the name and telephone number of a contact person of such. The bid letter should also contain a "letter of intent" from selected site. Once the bid is received by the AB, an AB member will make contact with the Area(s)/Region(s) to confirm the information received.

In addition, the Area(s)/Region(s) should have already selected the Admin part of the Bid Committee. This will allow the Bid Committee to become the Host Committee in order to immediately begin doing business if elected.

In the event that there are no bids received by the AB, prior to the convention or no bid is selected at the convention, the AB may, in its discretion, withhold an additional \$500.00 from the Book Purchase to seed an announcement material disbursement project. This will be to foster interest in ECCNA through mailings and outreach programs to the end that a bidder may come forward. These would be developed by the then-current AB as they see fit. Mailings will be facilitated by the AB Mailings Chair. Bid presentation fundraisers/gatherings/meetings/simulcasts, and such, could then be proposed and implemented by the then-current AB in a way that is suitable for the situation. In any event,

the AB shall move forward with its "Purpose", perhaps skipping a year, as the situation presents itself or until a new Host is found. If no bid is presented within 12 months of the last convention the corporation may be dissolved at the discretion of the AB. In that situation, all remaining funds would then be used to purchase basic texts, distributed equally among the regions on the East Coast.

Any Area/Region submitting a bid will be required to have a Bid Committee Representative attend the Bid Meeting at the convention to present their bid. The Bid Meeting is facilitated by the AB. The order of presentation is determined by the AB President flipping a coin (if two) or drawing straws (if more than two) in the presence of the Bid Committee Chairs during the meeting.

After each bid is presented, the floor will be opened for questions. The members in attendance will select the Host for the future convention at the Bid Meeting by paper ballot. Simple majority wins the vote. In case of a tie, the AB President will flip a coin, in the presence of all Bid Committee representatives, to determine the winner.

The new Host's contact person shall be immediately notified of this selection by the AB President and the selection will be formally announced at the current convention during the Saturday Night Speaker Meeting. The winning Bid Committee then becomes the Host Committee for the upcoming year and shall assume responsibility for the completion of the formation of the Host Committee.

Once a Host Committee has been formed, it becomes an active participant of the East Coast Convention, and is accountable to the Host Area(s)/Region(s) and the AB. The decision of an Area(s)/Region(s) to host ECCNA constitutes a binding agreement whereby that Area(s)/Region(s) agrees to abide by the existing ECCNA policy and fund flow guidelines. The Chairperson and Vice Chairperson of the new Host Committee automatically become members of the AB for the duration of the Convention.

After the winner is announced, the Administrative Committee immediately comes to task at the current convention by providing personnel to develop a pre-registration flyer and staff the next years' pre-registration table under guidance of the AB. Sale of pre-registrations by the new Host Committee may commence Saturday night through the close of the convention on Sunday.






